#### **Book Review.**

This edition of Montco-PSEA Retired

Newsline features a review of James A.

Duncan's political thriller, *Blood Republic*.



The reviewer is our very own Vice-President and legal scholar, Jules Mermelstein, Esq. His original review, somewhat edited for this newsletter, was written at the time the book was published in 2016, a few months before that year's presidential election. As you will see from the review that follows, the book's plot and message is as relevant today as it was some 7 years ago, so if you enjoy reading, and political thrillers are your go to for escapism in retirement, you may want to pick up a copy of Blood Republic the next time you are in the book store or library, or at least suggest it as the next book for your book club.

Here's Jules' review:

Imagine an America divided by ideology.

Neither side concerned with facts. Each side believing anything they find on the internet that confirms what they already believe. Each side not believing anything they find on the internet that contradicts what they believe.

Indeed, one does not need a great deal of imagination for this. Just log onto any social media site and follow the conversation while refusing to get drawn into it, and one can see it. Our civil society seems to be getting less civil and more accepting of fake news that confirms one's beliefs while less accepting of facts that contradict one's beliefs.

Now imagine an America in which conspiracy theories are not only believed, but might actually be real. An America in which the government uses the term *Islamic terrorists* against any group they want to either deny rights to or want to commit acts of violence against. An America in which the belief of alternative conspiracy theories causes people to react with violence against those they perceive to be anti-American.

Imagine the whole country divided, fighting, killing relatives on the "other side". Yes, another civil war. Now you have the plot of *Blood Republic*, one of the most intriguing, scary, and realistic-to-a-point political thrillers this reviewer has ever read.

Blood Republic was originally published on July 4, 2016, before the results of the 2016 presidential election were known. It revolves around a presidential election in which the Democratic ticket wins the popular vote but there is an apparent tie in the electoral vote as we head into actual voting by the electors. Given the Republican majority in the House of Representatives, it is assumed that if the electors tie, the House will award the Republicans the win.

The Republican side has a slogan of "Make America Great Again" and the Democrats champion a program they call voluntary but if someone elects not to participate they suffer a heavy tax burden for making that choice.

The Republican presidential candidate is an

elderly man with a large mop of blond hair who became famous through television, although as a televangelist, not by hosting a reality television show.

This dystopian novel of what our country may be becoming is eerily realistic, even if one does not buy the conspiracy theories within it.

The solution to prevent it is in our power.

Without giving away any plot lines, here is what one character says, which might very well be the moral of the story:

...Everyone needs the free will to make mistakes, travel their own path toward truth...With technology evolving exponentially, it won't be long before almost every individual has the ability to destroy us all, so if we don't have faith in a moral code beyond our personal interest, we're done. So it's just about your sincerity to that higher truth, only up to you and you alone.

In short, I highly recommend this novel to anyone with any ideology who is concerned with the level of discourse in the United States today.
