





## **Mideastern Region Events 2024-25**

*Region events listed below in order of appearance on our calendar – please be sure to RSVP! For information about statewide conferences and events, please see the link at the end of this document.*

Membership Recruitment Meeting (virtual) – Run by our Region Advocacy Coordinator, Adam Clark, this workshop is designed for local presidents and membership chairs to provide an overview of membership recruitment best practices.

Bucks/Mont Healthcare Consortium Labor Trustees (virtual) – Labor trustees in participating entities of this healthcare consortium meet monthly to discuss the agenda for the full trustee meeting held later that week.

Bucks/Mont Healthcare Consortium (in-person) – Labor and management trustees for the Bucks/Mont Consortium meet monthly at either the MER office or the Bucks IU building in Doylestown to discuss the business of the Trust.

CAPS Workgroup (virtual)– This group of individuals meet monthly to collaborate with and give direction to the PR firm that assists us in running our dues-funded media campaign, the Council for the Advancement of Public Schools.

EA Welcome Back Event (in-person) – A networking opportunity as we start the new school year. EA leaders from our region, bargaining team members, and our MAC committee are encouraged to attend to catch up with colleagues and meet members who are new to their leadership roles. It's not a timeshare presentation – enjoy some food and beverages with your union colleagues – that's it!

PSEA Board of Directors (in-person) – Per our region and PSEA bylaws, this group convenes in Harrisburg at our headquarters several Friday nights and Saturday mornings throughout the year to discuss the business of the Association. Our region representatives to this group are Bill Senavaitis (MER president), Bill McGill (MER president-elect), and Debbie Lee (MER vice president). We also have several other individuals who are active or retired members in Mideast serving in roles on the PSEA Board of Directors.

Learn-Engage-Lead – By invitation only, this program provides an opportunity to members who have shown an interest in Association leadership to learn more about their local, PSEA and NEA. We explore what characteristics are necessary for people to be successful leaders in any organization and look to the role of an Association leader as an organizer and advocate.

ESP Division Workshop/Meeting (in-person) – Support staff professionals in Bucks and Montgomery Counties are invited to attend these events to conduct the business of the Division and earn Chapter 14 credit on a variety of topics.

Executive Committee (in-person) – Local presidents, region officers, state committee members, and PSEA staff meet on the last Wednesday of each month to discuss the business of the Association. The content of this meeting is a critical link between the PSEA Board of Directors, our PSEA state committees, and our local leaders.

Coordinated Bargaining (virtual) – EA leaders and bargaining team members are invited to attend these meetings. Each time we meet there will be a presentation by PSEA staff about topics facing our local bargaining teams. Following that, local leaders have an opportunity to discuss the progress of their bargaining and any settlements that have been reached in our area.

MAC Committee Meeting (hybrid) – Our region’s Minority Affairs Committee increases awareness and encourages involvement on the part of ethnic minority members in programs on the local, region, state, and national levels. All members are welcome.

SEPaST (hybrid) – Participating entities in the SouthEastern Pennsylvania Schools Trust are invited to send representatives to these periodic meetings at the MER office to discuss matters related to healthcare.

EA New Member Welcome Event (in-person) – If you are a member in your first five years of employment in a public school, join us at the region office for a networking opportunity to learn about your rights as members of the Association.

Pre-Retirement Workshops (virtual or in-person) – These events, held throughout the year, are an opportunity for members in their last five years of service to learn about important matters related to PSERS and Social Security.

Act 48 Events – These continuing-education opportunities are offered throughout the year at a variety of locations for the purpose of furthering the professional development of our members. All events are eligible for Act 48 credit or, with pre-approval from your district, Chapter 14 hours. A full listing and description of all Act 48/Chapter 14 events for this year will be shared in September.

CTE Meeting - This group meets twice per year and provides Career and Technical Educators a forum to discuss current CTE issues and legislation that impacts their schools and programs. The group also offers CTE ACT 48 hours.

MER House of Delegates (in-person) – These events, held twice per year, are an opportunity for our 15,000 members to bring business for the consideration of the body. Along with updates from members of our Executive Committee, the evening features a cash bar, dinner, and region officer and committee elections.

ACE Training (in-person) – Hosted by PSEA Government Relations, this event helps EA and ESP members build relationships with their elected officials. The evening will cover important legislative topics, strategies for talking with friendly and unfriendly legislators, and how to maintain that relationship so that educators have a voice on important issues in Harrisburg.

CAPS Art Show Opening and Awards (in-person) – Students, families, and guests with work displayed at the art show are invited to attend an awards ceremony with light refreshments to celebrate their work.

CAPS Art Show Closing Reception (in-person) – Educators who have student work showcased at our art show at an off-site location are invited to attend a reception with light refreshments and beverages to celebrate their work.

CAPS Spelling Bee (in-person) – Student participants from across the region participate in a region event for the Scripps National Spelling Bee.
